Welcome & Introductions:

Discussions began with a brief reminder of workgroup purpose and desired outcomes:

- Gather qualitative information from patients about what they believe are the most important barriers and enablers for utilizing safety net dental services; and
- Compile information about safety net clinic capacity in a central resource to find information about dental services, make appropriate referrals, and potentially combine with other data to identify areas of need.

Capacity Survey:

- We revisited the purpose of the capacity survey: to make it easier for referring partners to help clients find dental care.
- We also discussed the importance of not re-creating the wheel and to build upon the good work of Access Partnership and 211.
- The group went through a template of basic questions (demographics, services, eligibility) and compared to questions asked as part of the United Way of South Hampton Roads. The group appreciated the format of the UWSHR questions and made recommendations to include questions related to accessibility, forms required to determine eligibility, specific sliding scale information and to also provide information regarding accessibility to care credit.

- Group excited about potential of replicating Richmond-area study which was created to better understand barriers to accessing dental services. Group also believes that applying for IRB is beneficial to ensure that the findings are publishable without issue.
