### State Budget and Oral Health Policy Update

#### **Governor Announces Biennial Budget**

Last week, Governor McAuliffe announced proposed amendments to the second year of the 2014-2016 biennial budget. Funding for [dental benefits for pregnant women enrolled in Medicaid and FAMIS](#) was included in the Department of Medical Assistance Services (DMAS) proposed budget.



Additionally, he introduced several amendments in support of Medicaid expansion. The legislature will consider the Governor's amendments as well as amendments introduced by other policy makers, and decide whether to keep the amendments or remove them from the budget.

Public hearings will be held on **Wednesday, January 7, 2015**, regarding the proposed 2014-2016 biennial state budget. For more information, [click here](#).
