### CDC Report Emphasizes Safety of Water Fluoridation

Health advocates and clinicians understand that fluoride is a safe, effective, and inexpensive way to prevent dental disease. Despite proven research, anti-fluoride activists use out-of-context findings or debunked reports to scare communities about fluoride's safety.

Unfortunately, the new National Health and Nutrition Examination Survey (NHANES) data may add fuel to the fire for the anti-fluoride community. The report found increased rates of fluorosis, a condition caused by high exposure to fluoride while the tooth is developing. While the CDC's National Center for Health Statistics (NCHS) released a report explaining that the results are not reliable, because of, among other things, inconsistent examinations and subjective scoring, we anticipate that the anti-fluoride community will try to use the data to further their message. You may hear from patients or other partners with questions and concerns about what these reports mean. Bottom line, water fluoridation is a safe and effective way to prevent cavities.

- Be an advocate: The community water fluoridation Rapid Response Team (RRT) members serve as local advocates, lifting up challenges to fluoridation, like the NHANES study, and sharing information on the importance and safety of fluoride. Join the RRT today.
- 2. Build trust in water by participating in community events: Raising awareness in the community on the safety of fluoridated water proactively is a great way to build trust. Preparing for the Census' Impact on Virginia's Health Programs





The census results are used to distribute billions in federal funds for programs like Head Start, SNAP, and Maternal and Child Health block grants. At the federal level, the Supreme Court heard arguments about the constitutionality of a citizenship question on the census. This guestion has the potential to limit

participation in the census, as it reinforces growing fears about immigration and deportation. and will likely result in undercounting as individuals choose not to respond at all, ultimately affecting Virginia's funding for important programs.

Because of the citizenship question, reaching out at the community level to build trust in the census will be important. However, as reported in <u>Virginia Mercury</u>, the Virginia General Assembly removed community outreach funding from the budget. On our <u>blog</u>, VaOHC CEO Sarah Holland shares the importance of a complete census count, and how health advocates can work to ensure a complete count of the populations they serve.
