## Join 70+ Organizations In Supporting An Adult Dental Benefit

In a letter to Virginia Governor Ralph Northam and Secretary of Health and Human Services Daniel Carey, 70+ Virginia organizations are urging the administration to include funding for a comprehensive adult dental benefit in Medicaid, in the 2020-2022 biennial budget. Virginia Medicaid does not currently cover comprehensive dental services, like cleanings, fillings, and root canals, for all adult enrollees. Join us in advocating for this crucial benefit by signing on to the letter.

Dental care is a major unmet need for newlyeligible Medicaid recipients, according to Dr. Jennifer Lee, director of the Department of Medical Assistance Services (the state Medicaid agency). Adding a comprehensive dental benefit will improve chronic disease management and keep individuals out of the emergency department, resulting in better health and cost-savings. Additionally, a benefit will support the Commonwealth's dental safety net by providing a much-needed revenue source; dental care is one of the costliest services provided by community health centers and free or charitable clinics.

#### Virginians See Cost as a Major Barrier to Receiving Care



Despite Medicaid expansion, adults still see cost as a barrier to care, according to the Virginia Consumer Healthcare Experience State Survey. In fact, 46% of respondents said they delayed care due to cost. Health and community providers can help improve consumer access to care by sharing information about Medicaid coverage and clinic locations.
