



Special Needs Dentistry You Can Do It! FAQ

Before attending the Special Needs Dentistry - You Can Do It! webinar series, find answers to your questions below. Remember to register for each session soon as space is limited!

1

Can dental and dental hygiene students attend the sessions?

Yes, anyone with an interest in the topic is welcome to attend, but the course is primarily intended for dentists and dental hygienists.

Do I have to attend all 5 sessions to get CE credit?

No, you do not have to attend all five sessions. However, we strongly encourage you to attend as many as possible because the information is all relevant, with each session building upon the information presented in the prior sessions. You will receive CE credits for each 2-hour session you attend. In addition, if you miss a session and there are more of the same Special Needs Dentistry – You Can Do It! courses available, you can pick up the session missed in the next course or “Cohort.” For example: If you missed Session Two of 2021 Cohort 1, then you could register for Session Two of 2021 Cohort 2.

I can't listen for the whole 2 hours, can I still get credit?

No, you must be present for the entire 2-hour session to receive CE credit.

When will I receive my CE information?

Kami Piscitelli will send out all CE information at the end of the 5-week course. We work hard to get these out as soon as possible, but it can take a week or two after the last session for participants to receive their CE confirmations. In addition, your course evaluation must be completed before the verification of attendance is emailed to you.

What are all the requirements to receive my CE information?

1. Register for each session you plan to attend. If you are sharing the screen with someone else, each person must register individually.
2. Attend and participate in the entire course! Dr. Cooke will be using polls at various times to gauge your participation and engagement level.
3. At some point during the course, enter your full first and last name in the chat box. You can do this privately to the moderator or to the group. If you are sharing your screen with someone, all registered attendees must enter their full name in the chat box.
4. After the course is complete, make sure you finish the full course evaluation required. The course evaluation will come to you via email with a Survey Monkey link. The course evaluation must be completed within five business days.

Will the sessions be recorded? Can I re-watch later and take notes, or can I watch later to get CE?

Course sessions may not be available for future viewing. A possible recorded option is being determined. You will be notified via email if this becomes an option, but not at this time. You must watch them live to qualify for CE trainings.

Can I attend the course more than once?

Yes. However, you are only eligible for ISHCN CE credits once per year. The maximum number of ISHCN CE you can receive through these trainings per year is 10 CE.
