Clinical Resources

- Safety-Net FAQ (Dr. McAllister Castelez)

This is an FAQ for providers and safety net clinic employees. It answers questions about COVID-19, including what to do in dental clinics in Virginia, and how to keep patients and employees safe.

- <u>Minimally Invasive Treatments for Dental Emergencies</u> (Dr. McAllister Castelez)

This resource lists different methods of treating various dental emergencies without using aerosols or surgery and includes recommendations for each method.

- Dental Emergency Workflow (Dr. Scott Wolpin)

This workflow was created to determine if a patient is having a dental emergency, and the steps to take when providing care.

- <u>ADHA COVID-19 Resource Center</u> (American Dental Hygienist Association – ADHA)

The ADHA COVID-19 resource center includes advocacy information, clinical resources, and an FAQ section. It is continually updated with new information.

- Executive Order Limiting Dental Care

Governor Ralph Northam issued a statewide order postponing elective surgeries and dental care. Of note, Executive Order of Public Emergency Two:

- Restricts dental offices to emergency-only care as discussed in the ADA guidance
- Restrictions end on 24 April 2020
- Considers safety of clinical staff and patients
- Does not mandate other restrictions (e.g., treatment in negative pressure isolation rooms)

- <u>Pediatric Practice Management Tips During COVID-19 Pandemic</u> (American Academy of Pediatrics - AAP)

The AAP has shared tips for pediatric practices during COVID-19. The website includes information on small business loans, unemployment, FMLA and OSHA guidelines, telehealth, staffing concerns, and workflow.

- Interim US Guidance for Risk Management and Public Health Management of Healthcare Personnel with Potential Exposure in a Healthcare Setting to Patients with Coronavirus Disease (Centers for Disease Control - CDC) The CDC is updating this webpage with guidance for public health professionals regarding COVID-19. It includes definitions of risk categories as well as recommendations for exposure management.

- <u>Guidance on Preparing Workplaces for COVID-19</u> (Occupational Safety and Health Administration - OSHA)

This guide from OSHA includes recommendations and descriptions of mandatory safety and health standards and includes information on exposure risk management for employees.

Policy Resources

Stimulus Package Resources:

- Stimulus Phase One: Coronavirus Preparedness and Response Supplemental Appropriations Act includes extra funding for government agencies: CDC, FDA, NIH, SBA (Small Business Association), and USAID (United States Agency of International Development). It includes \$4 billion to make more coronavirus tests available and \$1 billion in Ioan subsidies for small businesses.

- Stimulus Phase Two: Families First Coronavirus Response Act includes among other things:

- A temporary 6.2% increase in the federal medical assistance percentage (FMAP) for state Medicaid programs.
- Coverage for COVID-19 testing with no cost-sharing across public health insurance programs.
- Provides states with the option to extend Medicaid eligibility to uninsured individuals.
- Requires (most) employers to provide paid emergency family leave to employees.

Our friends at the National Conference of State Legislators (NCSL) have created an in-depth analysis <u>here</u>.

- Stimulus Phase Three: Coronavirus Aid Relief and Economic Security Act is expected to be signed into law as early as today (Friday). This act is a massive spending bill with many details, to help make sense of it, NCSL has shared an in-depth analysis, available <u>here</u>. Of note:

 Nonprofits with 500 or fewer employees will be eligible for loans of up to \$10 million, with expedited loans of up to \$1 million available for payroll, including paid leave, as well as health-insurance premiums, facilities costs, and debt service. Nonprofits that keep their employees on the payroll from February 15 to June 30 could have their loans forgiven. **Subscribe**

this includes \$100 billion for grants to hospitals, Medicaid and Medicare suppliers, and health clinics.
