ADA HPI Data Shows Dentists Reopening Though Challenges Remain

The American Dental Association's Health Policy Institute (ADA HPI) is conducting biweekly surveys to understand the impact COVID-19 is having on dental practices. Data from the most recent survey that spotlights the reopening of dental practices across the country was shared in a <u>webinar</u> this week. Of note:

- Dental practices are returning to operations: The data from the week of May 4 shows a significant increase in the number of dental practices that are entirely operational, (from 3.4% the week of April 20 to 30% the week of May 4).
- Patient volume and collections remain low: In states like Virginia that have reopened dental practices patient volume is 28% of what it would be normally. This along with collections that are 20% lower than they normally would be means that while dental practices are beginning to see patients again, the revenue generated is still behind what it would be under normal circumstances.
- PPE is still in short supply: ADA HPI added a new question in their most recent data collection, asking providers about their PPE supply. While the return to work is a positive sign for the economic impact of COVID-19, concerns remain around PPE. 30% of survey respondents reported they have no N95/K95 masks.

In addition to the national results, ADA HPI now has state-specific data available. In the most recent survey, 62.2% of Virginia dentists said they were seeing patients though at a lower volume than normal. With this return to work, Virginia dentists are beginning to pay their staff again, 44.4% report paying their staff fully.

Policy Resources

Congress is considering next steps for a phase four stimulus package. To ensure oral health is a priority, Virginia Health Catalyst, along with a broad consortium of state and national partners are advocating for three specific requests to ensure oral health needs are recognized as part of the response:

- An increase in the Federal Medical Assistance Percentage (FMAP) by 12%
- An increase of the FMAP for Medicaid dental services by 5%
- Funding to state health departments and oral health programs to support oral health infrastructure

FMAP refers to how much the federal government pays to support state Medicaid programs – any increase frees up state funds. These requests, if included in the stimulus package, could have direct implications on states' ability to support Medicaid adult dental coverage – especially crucial for us in Virginia.
